Please find the info for the complaint on the criminal misconduct of Sheriff Jeff Grey, Prosecutor Matt Fox and BCI employee Chris Hamberg:

I have been informed by your staff member Matt Hilbert that the task force to investigate this crime would include Sheriff Jeff Grey and Chris Hamberg from BCI-----Mr Dewine you have a dilemma the criminals are the ones investigating their own illegal actions----therefor the evidence that I am going to present is limited-----at this point WE WILL NOT RELEASE THE NAMES OF OUR INFORMANTS NOR OUR VICTIMS UNTIL YOU TURN THIS OVER TO A TRUE INDEPENDENT AGENCY:

Section 2: In this section your staff sent me a complaint form for organized crime and the drug trade. Mr Dewine----this orchestrated cover-up of institutional rape is an "organized criminal activity" by definition of organized there are multiple parties all of which have vested power to the public's best interest. Under Ohio law ORC 2151.42----when Father Dorn—two parents and others reported the location and nature of this crime----Sheriff Jeff Grey, Chris Hamberg and later prosecutor Matt Fox had a legal responsibility to "pass" this on to where the crime occurred which was Findlay in Hancock County---we have documented proof that this NEVER happened. In addition ORC 2921.31 requires that a crime of the magnitude of "rape" necessitates a "best effort" to investigate----by these authorities not contacting Findlay and by not contacting The Red Roof Inn to check for evidence they are guilty. Due to the fact that each safeguard for the public failed and it is obvious that this was a "deliberate" attempt not to pursue criminal action against certain parties----the mere coordination of this makes it organized and the violation of two laws in Ohio make it an organized criminal action by Jeff Grey, Chris Hamberg and Matt Fox.

This crime occurred in Hancock County, however the crime was reported by Father Dorn the priest at Mary Help of Christians Fort Recovery and two parents/school official----to sheriff Jeff Grey who did have contact with detective Chris Hamberg to cover-up this crime.

Witnesses: WE CAN NOT GIVE THE NAMES OF ALL OF OUR WITNESSES UNTIL WE KNOW WHO IS INVESTIGATING AS OF NOW CRIMINAL JEFF GREY AND CHRIS HAMBERG OUR INVESTIGATING THEIR OWN CRIME:

Detective Jack Bastian----has met with victims, parents and priest and has audio tapes of testimony

Sheriff Jeff Grey----we have documents to verify that Mr Grey was alerted to a crime involving the rape of boys by a required reporting authority in a meeting Priest Father Dorn, parent and school official are all on record this occurred and Mr Grey had a legal duty to send this to the jurisdiction which was The City of Findlay—WE HAVE DOCUMENTS TO PROVE HE DID NOT----this is a crime under ORC 2151.42 and ORC 2921.31

BCI agent Chris Hamberg like Mr Grey had the same responsibility and he also violated the law----THE QUESTION IS WHY DID THE OHIO ATTORNEY GENERALS OFFICE HIRE HIM SO QUICKLY AFTER THIS CRIME COVER UP-----WAS IT A PAY OFF???

Father Dorn---now at Holy Redeemer New Bremen---we have three audiotapes of what he told Sheriff Jeff Grey and we have tapes on what he knows was alleged to have been done to the victims.

Parent A----met with Father Dorn and can testify that there was a cover-up

School Official B---can verify that he also conveyed info to Sheriff Jeff Grey and Grey did NOTHING

Victim A----on audio conveys the tradition and abuse of student athletes---it is a rite of passage in The Fort Recovery School System.

Victim B----verifies existence of spirit stick and hazing and his medical records need pulled he was treated for Anal damage from the sodomy

Victim C----was violated with a coat hanger and is difficult to reach----will require a sub poena

Victim D----admits to hazing---appears this party went on to become a violator---also reported that this individual received a negotiated payment for silence.

Victim E----no longer lives in area he will require a subpoena.

Findlay Authorities-----Have ZERO documents of being contacted!!

Findlay University----Have ZERO documents of being contacted!!

Mercer County sheriff Office has ZERO documents of investigation or meeting!!

Section 3---- Documents to support:

We have 11 audio tapes verifying and piecing together this crime-----WE CAN NOT RELEASE THESE UNTIL WE ARE ASSURED THEY WILL NOT GO TO JEFF GREY OR CHRIS HAMBERG

In addition we have witnesses that have agreed to speak to the FBI and we believe they will speak to your officials if we can clarify that it is SAFE to do so.

Section 4 Law Enforcement contacted:

Mercer County Prosecutor Matt Fox was notified early in the investigation and he has done NOTHING--- he is guilty of violating ORC 2151.42 and ORC 2921.31 and he needs to be charged.

BCI agent Chris Hamberg also guilty as explained earlier

Mercer County Sheriff Jeff Grey guilty as explained earlier.

FBI---has now opened an investigation.

Ohio Attorney General Officer Matt Hilbert has been notified through the process.

Findlay Ohio Police department verifies zero contact and documents.

Mercer County Sheriff's Office documents verifying zero investigation.
